

# 2024-2025 OACA MEMBERSHIP APPLICATION

Membership is open to all high school, middle school and college coaches. Athletic Directors, youth and volunteer coaches are also eligible. **Gold Card Membership** is open to those who are certified through the OSAA Interscholastic Coaching Courses (must have completed either NFHS Fundamentals of Coaching or OSAA Beyond the Scoreboard certification) and college coaches. A **Retired Gold Card Membership** is offered to retired coaches *who are no longer coaching or teaching* and have coached at least 10 years in Oregon at the middle school, high school, or college level.

- 1. Regular Membership may be purchased by any high school or middle school coaches and Athletic Directors. <u>Does not</u> <u>permit free admission to High School/OSAA events.</u> \*
- Only those who are certified through the OSAA Interscholastic Coaching Courses and college coaches may purchase a Gold Card Membership.
- 3. Retired career coaches may purchase a Retired Gold Card (see above).
- 4. Membership cards are **<u>non-transferable</u>** and are for member use only.
- 5. A valid email address is required for each member as membership cards will be distributed digitally.

#### \*The Gold Card entitles the member to regular benefits as well as admission to OSAA-sanctioned high school and championship events. Picture ID will be required for use of Gold Membership Card when attending events.

# GENERAL LIABILITY INSURANCE

This policy will provide general liability coverage to the Oregon Athletic Coaches Associations and its high school and middle school members. Coverage is effective from Aug. 1, 2024 to July 31, 2025.

#### LIMITS OF INSURANCE

#### **Coverages Provided by this Policy**

- Educators Professional Liability
- Participant Legal Liability for insured members
- Liability assumed under insured written contract
- Defense Cost outside limits

Exclusions

- The use of automobiles, buses, watercraft and aircraft
- Property of others in the care, custody, and control of the insured
- This insurance does not apply to members that coach at an All-Star game that is not approved by your state coaches association
- This insurance does not apply to members working overnight camps

#### **CAMP & CLINIC COVERAGE**

Today, most coaches are involved in some type of sports camp. Please note that our General Liability Program follows insured members while working at camps and/or conducting their own personal camp.

In addition, Participant/Accident (Medical) coverage is available for coaches and/or participants. Should an accident occur during a camp, clinic or event, this secondary coverage helps offset the loss suffered by families affected by such accidents.

#### PROCEDURE FOR CAMP INSURANCE

- Signed waivers (registration form) must be in place for all participants attending camps. The waiver must have indemnification language and acknowledgement that primary medical insurance is in place for the participant.
- If you cannot secure such a waiver, you must purchase Participant/Accident (Medical) coverage for all attendees.
- If you require a certificate of insurance naming an additional insured, you
  must purchase the Participant/Accident (Medical) coverage for all
  participants attending your camp.
- If you require a certificate of insurance showing proof of insurance and have the required waiver in place, you do not have to purchase the Participant/Accident (Medical) coverage.
